Framed by the iconic MacDonnell Ranges and surrounding desert landscape, Alice Springs is the place to begin your outback adventure. Alice Springs is a melting pot of culture, art, history, entertainment, and adventure.

Mparntwe (pronounced m-ban tua) is the Arrernte (pronounced a-run-duh) word for Alice Springs. The Arrernte people are the traditional custodians of Alice Springs and have a strong connection with the land. According to the Dreamtime, the town of Alice Springs and the MacDonnell Ranges were created by the actions of several ancestral figures including the caterpillar beings Ayepe-arenye, Ntyarlke and Utnerrengatye.

ADVERTISING

A-Frames must be kept within the boundaries of your stall and not in walkways.

Bump In

Stall holders are permitted to start constructing their sites from Monday of show week during the below hours. All sites must be completed by 8pm on Thursday. If you arrive prior to Monday, please do not move onto your site as this can cause delays in our team marking out trade sites.

Monday - Wednesday 8.30am - 4.30pm
 Thursday 8.30am - 8pm

Stall sites are for ground space only. Shade, partitions, marquess etc are not included. All stall structures, shade and displays are to be located within the boundaries of the site. Please ensure correct dimensions are recorded on your application and any exhibition company requests.

Bump Out

Pavilion stalls may pack down on Saturday night only if they are attending the Sunday Todd Mall Markets. **No vehicles can be moved, items must be carried to your vehicle.**

Bump out is from 8.30am - 3pm on Sunday and from 8.30am - 2pm on Monday. All stalls and structures must be removed by 3pm on Monday. Please leave your site in a clean and tidy manner.

CAMPING

A limited number of camping sites are available from Friday 26th June - Monday 6th July.

SMOKE FREE EVENT

The Alice Springs Show is a NON SMOKING event. Designated smoking areas are allocated. Penalties may apply for any non-compliance to the Tobacco Control Act.

ENTRY PASSES

All site holders must have an entry wristband to gain access to the Show.

Security guards will be at the gates checking for wristbands so please ensure you and ALL your staff have their wristbands on their arm.

Site holder passes can be purchased on our website or from the Show Office.

FOOD STALLS

Showmen's Guild exclusive items are Dagwood Dogs (also called Pluto Pups, Sausage on a Stick), Fairy Floss, Waffles, Toffee Apples and Snow Cones. Sale of these items is strictly limited to members of the Showmen's Guild and only in the Showmen's Guild area.

Food Court: One site allocation will be permitted per company or entity in the Food Court area. All food stall operators must be registered to trade in the Northern Territory and hold a current Food Handler Permit to be displayed at all times.

GLASS

Blatherskite Park is a glass free venue

LIVESTOCK MOVEMENTS

Any identifiable livestock moving on or off the Show Grounds for the Show must have at a minimum, a NT Waybill, including livestock pets. Further information can be found at the NT Government website.

INSURANCE

All stall holders must keep policy of insurance indemnifying them against public liability in the sum of \$2,000,000 for each incident and \$10,000,000 for the Show. The Society reserves the right to inspect the policy of insurance at all times. A Certificate Of Currency must be provided to the Society on application. Public Liability Insurance must be current for the duration of the Show including set up and dismantle times

Stall holders are reminded that they are responsible for insuring their own property, vehicles and goods.

LOTTERIES, GAMES OF CHANCE

All games of chance, and raffles for fund raising are strictly prohibited without written permission from the Society and must be carried out in accordance with the Gaming Control (Community Gaming) Northern Territory Regulations.

PARKING ON THE GROUNDS

There is limited parking space on the grounds. All exhibitors must park in designated areas.

During Bump In vehicle access is through Gate 1 (Main Gate). Vehicles can not block roadways or other sites at any time.

Each site comes with 1 vehicle pass. Vehicles can be driven to stalls to unload any late minute items until 8am on Show Days.

ONE Additional Vehicle pass can be purchased for \$5.00

POWER, ELECTRICAL ITEMS & GAS

Any electrical equipment or gas appliances not listed on the application form must not be utilised.

All power leads used on the Show Grounds must have a certified date of inspection tag and be recorded on a numbered register to be provided to the Society, or regulatory authority on request.

All exhibitors using Show power of any description are required to provide and use residual current device (RCD). The Society has the right to remove any lead or junction box not in compliance. All traders must read and comply with the NT WorkSafe Guide.

Any Electrical work for your trade space must be done by a licensed electrical contractor at your own expense.

Power supply to the site is subject to any conditions laid down by Power and Water agency. The Society cannot guarantee power as it is subject to being supplied by the Power and Water agency.

All Food Vendors must have an approved fire extinguisher at the site at all times. The fire extinguisher must have a current and valid test tag within 6 months.

PRESENTATION OF STALL / STAFF

Stall holders should encourage staff representing their products to be well presented and to dress in relation to the exhibits design or theme. Stall space must be kept tidy at all times

PROHIBITED ITEMS

No article that creates nuisance, annoyance, is dangerous, or of offensive nature may be displayed, sold, or given as a prize. The supply of certain other products (e.g. illicit drugs, weapons, chemicals/substances, etc) are also banned. This includes any type of projectile gun. These and other products are listed on our website and are subject to mandatory standards and/or bans.

Please note any type of mask or bandana that obscures the face in part or full is banned.

REFUNDS

If the Society finds it necessary to cancel or postpone the Event, this contract shall cease to operate upon notice, being served on the Exhibitors at the address provided to the Society and no compensation shall be payable to the exhibitor.

CASS reserved the right to cancel applications and retain all money in connection therewith if there is any infringement of the foregoing conditions.

Site bookings cancelled prior to 1 June will receive a 75% refund. No refund will be given for bookings cancelled on or after 1 June 2026. The Administration fee is non-refundable at any time. If cancellation is required for a medical reason, a signed medical certificate must be provided, for the refund less administration cost. Written notice of cancellation must be received by 1 June 2026. All refunds are at the discretion of the CASS committee.

RUBBISH & WASTE REMOVAL

Exhibitors are responsible for the immediate removal of all rubbish from their sites and to ensure stalls are kept clean, tidy and presentable at all times.

- Please use designated bins for cardboard.
- Food oil must be disposed of in the Food Oil waste bin located behind Greatorex Pavilion.

Other waste such as electrical equipment, white goods and chemicals must be disposed of responsibly at the Alice Springs Waste Management facility on Commonage Road, at the Exhibitors expense. Blatherskite Park is a public reserve and littering is an offense.

SECURITY

Security will be present throughout the event and overnight grounds security is provided via surveillance. CASS takes no responsibility for any lost or stolen goods.

After Hours: Pavilions close at 5:00pm and are locked shortly after. Camera surveillance is onsite from Monday 29 June - Saturday 5th July. Security personnel are in attendance on the grounds from Thursday evening through to Sunday morning,

SHOW ENTRY & PASSES

Each site comes with 2 x Two day entry passes. Additional passes (single or 2 day) can be purchased for a discounted rate when applying for your trade space or during Show week. **No replacement will be offered for lost, stolen or damaged passes.**

SHOW BAGS

No exhibitor will be permitted to sell Show Bags without the permission of the Society. Exhibitors selling Show Bags are to present a sample of each type of bag to the CASS Inc office by 12pm on the Wednesday before the event for inspection by NT Police and CASS Inc for compliance. It is the responsibility of all stallholders selling toys and Show Bags to make sure that any products sold to children are safe and do not contain any products that are banned in Australia.

BOND -A \$100 bond for trade spaces will be refunded after the event, subject to compliance with pack-down times, safe vehicle access procedures, and the trade area being left in a clean condition.

Late applications will incur a \$95.00 late fee on top of their site and admin fee after 15th June 2026.

PAYMENT & TERMS

- All trade space site fees MUST be paid by 1st June 2026, or you may forfeit your trade site.
- Once your trade application is approved, you will be notified to log back in and pay a 50% deposit to confirm your spot. No application is confirmed until the deposit has been paid.
- A refundable bond of \$100 will be introduced for all trade spaces. Please note that the bond will be forfeited if you or your staff/volunteers are observed commencing pack-down before the official close of trading, operating vehicles in the pedestrian area, moving fencing for access to load vehicles or leaving rubbish or your trade area in a messy state.
- A late fee of \$95 will apply to all bookings made after the 15 June 2026.
- Refund: Site bookings cancelled prior to 1 June will receive a 75% refund. No refund will be given for bookings cancelled on or after 1 June 2026. TERMS & CONDITIONS FOR TRADERS

The President or their representative reserves the right to refuse any application. The Alice Springs Show is a NO SMOKING event. Designated smoking areas are allocated. Penalties may apply for any non-compliance to the Tobacco Control Contact.

1. All Trade Space exhibitors must report to the Central Australian Show Society Inc. office at the Showgrounds on arrival to collect your Show Pack. Exhibitors are not permitted to occupy space allotted until 5 days before the event or another date as advised by the society. Trade space is to be used solely for the purpose specified on your application. Trade space site to be vacated no later than 11am on Sunday following the Show. Exhibitors are required to keep and leave sites clean. Blatherskite Park camping fees are applicable if you remain on site after Sunday 11am. Camping arrangements outside of this time can be organised by emailing admin@blatherskitepark.com.au.

2. The Exhibitor or any party has no right to occupy, use or advertise the use of the site until the application has been approved in writing from the society. There are no perpetual sites allocated at the Show. Any requested location must be submitted to the Society.

3. Site preparation MUST be completed by 8.00pm Thursday prior to the Show. Exhibitors not complying with this requirement forfeit their site.

4. All exhibits must remain in operation from 9.00am to 5.00pm on Friday and Saturday. Pavilions will be locked from 5.00pm to 7.30am. Vehicle movement within the grounds is prohibited until 7.30pm. All vehicles must exit via Gate 4.

5. Signage displayed by exhibitors must relate to the products which the Society was advised would be promoted. Any other signage promoting other products or service must have prior written approval from the Society or their representatives.

6. There is limited parking spaces on the grounds. All exhibitors must park in designated areas. Vehicles parked in unauthorised areas will be clamped or towed away and impounded.

7. The Society reserved the right to regulate the use of equipment on display sites which produce excessive noise and cause annoyance to other exhibitors and the public. No loudspeakers are to be used without permission of the Society.

8. No Exhibitors shall;

- a) Erect barriers to prevent uninterrupted passages of the public between exhibits.
- b) Erect display signs in a such a manner to cause inconvenience to other exhibitors.
- c) Paint or mark any Park property without the authority of the Society
- d) No barriers of any description are to be placed over or in front of any fire fighting equipment or electrical control boxes.

9. Exhibitors hereby accept all responsibility for any damage or injury to any person, or person property which may arise out of the use of any machinery, or item used in connection with the exhibits. Exhibitors agree to carry out all activities within the requirements of Blatherskite Park and any Act of Parliament which may govern the erection or structures, displays, the sales of machinery and other products. The Society requires compliance with any ordinances or regulations made by any Government, semi-government, or local authority including the requirements of the Northern Territory Food Act.

The Society reserves the right to inspect the policy of insurance at all times. A Certificate of Currency must be provided to the Society on application. 11. No sub-letting will be permitted unless by special written permission from the Society.

12. Exhibitors and their employees/volunteers shall conduct themselves in a respectful manner and maintain a neat and clean appearance.

13. Plans and specifications of any temporary structure must first be approved by the Society in writing before building operations can commence.

14. If the Society finds it necessary to cancel or postpone the Event, this contract shall cease to operate upon notice, being served on the Exhibitors at the address provided to the Society and no compensation shall be payable to the exhibitor.

15. CASS reserves the right to cancel applications and retain all money in connection therewith if there is any infringement of the forgoing conditions.

Blatherskite Park is a public reserve and littering is an offense.

17. All food exhibitors must have an approved fire extinguisher at the site at all times. The fire extinguisher must have a current and valid test tag within 6 months.

18. Any electrical equipment or gas appliances not listed on the application form must not be utilized. All power leads used on the Show Grounds must have a certified date of inspection tag and be recorded on a numbered register to be provided to the Society, or regulatory authority on request.
